A football agent accused an ex-executive of Chelsea repeatedly lying about a tax for the club to avoid paying it, said Southwark.

During an appearance at times irascible as a witness, the agent Saif Alrubie said that the ex-director of football Chelsea Marina Granovskaia defamed West Ham as having paid the club in London by the defender French Kurt Zouma 7upbet 2024 – effectively cutting him out of the deal and depriving him of taxes.

After pursuing the alleged debt 7upbet an e-mail in May 2024, Alrubie was arrested in the month when he disembarked on a plane that landed in the city. He was then interrogated by the police about the sending of a "communication electronically with intent to cause distress or anxiety".

Alrubie denies that he is guilty of committing a crime contrary to the Malicious Communications Act 1988 and says, 7upbet 7upbet message was only trying to "transmit the threat of legal action".

"She is a liar", said Alrubie to the court about Granovskaia.

The jury had already heard earlier that Granovskaia had said to Alrubie 7upbet 2024, in general terms he would receive a commission if Zouma was sold for more than £30 million.

There is a dispute between the prosecution and the defence over the exact value of the transfer of Zouma. However, Granovskaia said in court on Wednesday that West Ham paid £29 million to Chelsea including "add-ons".

Alrubie said he sent the e-mail in May 2024 to collect 300,000 7upbet commissions, as he believed they would be his debts under the agreement.

His comments about Granovskaia came 7upbet a day when he was repeatedly warned by the judge in the way he was answering questions in the witness box, with the witness frequently saying to Arizona Asante that his questions were "irrelevant".

In one instance, the judge Tomlinson declared 7upbet voice: "Pare! Pare!" before instructing the witness.

The jury also heard from another football agent, Barry Silkman, who had worked with Alrubie on the transfer of Zouma to West Ham and said he had been informed by the largest shareholder of the Western clubs about the payment of £33.9 million. "I asked David Sullivan what this deal was about", he said.

A message allegedly threatening Alrubie to Granovskaia 7upbet in May 2024 declared: "I am sure you heard about the story about your other friend KIA [Joorabchian, a football agent] when he owes me money for 1 year and how he ended up paying. I don't want the same problem with me".

Alrubie disse ao júri que houve dois episódios, com ele falando sobre um incidente 7upbet 2009 durante 7upbet entrevista policial.

Na quarta-feira, o tribunal ouviu como Joorabchian havia secretamente voado para os EUA na noite anterior a ele deveria dar provas no julgamento.

Os membros do júri foram informados aos jurados que esperavam ouvir as principais evidências de Joorabchian na terça-feira. No entanto, eles receberam informações da promotoria sobre o fato dele ter levado um jato particular para os EUA segunda à noite sem informar ao tribunal e agora ele não aparecerá como testemunha ”.

O caso continua.
