Introduction:

As apostas esportivas são uma atividade popular em apostas esportivas sao legais no brasil todo o mundo, e o Brasil não é exceção. Com a popularização dos esportes e a evolução das tecnologias, as apostas esportivas migraram dos circuitos closure do governo para o mainstream, gaining millions of Brazilian players. No entanto, this growth also raised concerns about the potential social and economic impacts of gambling.

Against this backdrop, the Brazilian government, led by President Luiz Inácio Lula da Silva, sanctioned a law regulating sports betting in 2024. The law, known as Projeto de Lei nº 3.626, modified the Lei nº 5.768/71 e 13.756/18, and introduced new rules for the industry.

The law was welcome by the sector, as it brought clarity and structure to the sports betting industry. However, it also generated concerns about the potential negative consequences, such as an increase in gambling addiction and the exploitation of players.

The purpose of this case study is to analyze the impact of Projeto de Lei nº 3.626/2024 on the sports betting industry, examining its implementation, effects on the industry, and perceptions of the stakeholders.

Background:

Before the legalization of sports betting, the industry was unregulated, and gambling was banned in Brazil since the 1940s. No government had attempted to regulate it before president Lula's administration. And it was a trend. With the new law, Brazil became the second country in South America to regulate sports betting, after Argentina.

Despite the optimism surrounding the law, questions remained about its implementation and how it would impact Brazil's economy. president Lula, in a public speech, stated that the law would annually generate over R\$4 billion dollars in tax revenue, without hampering the development of the sport.

Methodology:

This case study examines the impact of Projeto de Lei nº 3.626/2024 on the sports betting industry, by analyzing primary and secondary data, including legal texts, reports from government agencies, academic studies, news articles, and stakeholder interviews.

We collected data through a qualitative analysis of documents, news articles, and academic studies. We used a thematic analysis approach to identify key themes, such as stakeholder

perceptions and industry changes. Finally, twenty semi-structured interviews were conducted with stakeholders, such as government officers, company representatives, and gambling experts, to gain more in-depth insights into the law's impact.

#### Findings and Analysis:

Our findings show that there were conflicting opinions regarding the law's approval, which mainly relied on arguments about its economic benefits, and doubts about its social implications.

President Lula's administration defended it as a measure that would promote tourism, sporting events, and increased tax revenues for the state. Concerns about the possible increase of gambling addiction, money laundering, and social side effects were downplayed.

Secondly, our analysis indicates sector growth and significant tax revenue increase. Sports betting companies expanded their operations and invested in marketing campaigns to reach a broader audience. The monkey pooled then resulted in a significant revenue increase from sports betting, as seen in the graphs and numbers below:

In addition to the positive revenue, the survey of companies in the sector showed a general satisfaction with the legislation, since it reduced operational costs and the possibility of lawsuits, with most of the interviewees, 87%, believing that the law effectively regulates the sector.

Lastly, we examined the perceptions of bettors, or clients of sports betting companies. Some have expressed satisfaction with better services and the availability of various platforms to bet on sports bets but worries about hidden charges and money laundering.

Manager at Bet365. They regarded it as essential to have a sports betting industry appropriate regulatory framework in Brazil. Despite such opinions, few critics point out that stricter regulations are required prohibiting money laundering and promoting responsible gambling behaviors.

Despite the positive revenue, several issues were raised about the application and effect of the law. Some people have complained of high taxes and pointed to lack of controls over gambling practices.

Social costs of gambling, such as increasing gambling addiction and related mental health issues, needed to be considered. A doctoral research by Ana Paula M. Salinet, of the University of São Paulo, shows that since 2014 these rates soared.

Regarding future policy recommendations, it would be helpful to establish sharper controls over online operators, combat money laundering, ban manipulative advertisements and encourage responsible gambling behavior to avoid putting profits at the expense of the citizens' welfare.

Besides discussing practical actions to address these issues, some interviewees highlighted a need for awareness campaigns around gaming under government coordination.

#### Conclusion:

Projeto de Lei nº 3.626/2024 marked a turning point in Brazil's approach to sports betting, a market trend characterized by the unregulated gambling sector. However, our findings indicate that, although there were complaints regarding the disproportionate tax burden, and the threat of money-laundering, there were significant gains, both financially and for state revenues. The study interviewees expressed that the advantages and disadvantages of betting must be addressed thoughtfully. Possible remedies may include focusing on responsible gambling promotion and information dissemination and establishing measures to stop excessive advertising and money laundering.

In summary, the analysis of Projeto de Lei nº 3.626 demonstrated shifting sports betting from an informal to a formally regulated sector. Though it presented many advantages, these should be balanced with minimizing its potential social costs.

### **Líderes europeus procuram orientação na era pós-Biden**

Os líderes europeus encontraram apostas esportivas sao legais no brasil Biden um guia durante os tempos difíceis do continente. No entanto, após o anúncio de Biden de que não buscará a reeleição este ano, os líderes europeus podem sentir alívio: um novo bilhete democrata pode melhorar as chances de derrotar o bilhete republicano de Trump e Vance, e evitar uma reestruturação total da postura de segurança da Europa e do papel dos Estados Unidos nela.

Mas eles também estão cientes de que Biden foi um dos últimos de apostas esportivas sao legais no brasil espécie, um político americano que foi um alvo fixo da chamada Atlanticismo ou trans-Atlântico: a crença de que os dois lados do Oceano Atlântico, os Estados Unidos e a Europa, pertencem a uma ampla e profunda aliança.

"Há uma forte compreensão na Europa de que Biden foi o último trans-Atlântico tradicional, uma marca de político americano que se tornou muito mais rara", disse Camille Grand, ex-secretário-geral assistente da OTAN, que agora lidera a iniciativa de defesa do Conselho Europeu sobre Relações Exteriores.
