Justin Timberlake Expected to Appear Personally in Court in the Hamptons

It is expected that Justin Timberlake will appear personally in court in the Hamptons on Friday in his case of driving while intoxicated, according to reports that indicate he will admit to a traffic violation.

The awaited appearance of Timberlake in the local court of Sag Harbor is derived from his arrest on June 18 after he allegedly drove through a stop sign and veered from his lane. The singer was charged with the lesser offense of driving under the influence (DUI).

Arrest Details

According to a criminal complaint filed against Timberlake, the police officer declared: "His eyes were injected with blood and watery, there was a strong odor of alcoholic beverage from his breath, he could not divide attention, he spoke slowly, he stumbled while walking and he performed poorly in all sobriety tests administered on the field".

It is reported that Timberlake told the police officer he had consumed a martini and was with friends in his car from the American Hotel restaurant, a nearby and popular establishment. It is reported that Timberlake refused to take a breathalyzer test and spent the night in custody at the local police station.

Arrest Repercussions

A video of Timberlake at the police station went viral immediately and was used as the basis for art projects in Sag Harbor. Timberlake was declared innocent during a virtual court appearance in August. The judge in charge of the case suspended the driving license of the singer and producer, member of the popular and long-running band 'NSync.

It is anticipated that Timberlake will enter a plea of guilty during his court appearance in person later in the week. It is reported that Timberlake has arranged a deal to resolve his DUI case, which includes a plea of guilty and the payment of a fine, which would bring an end to the criminal case.

A spokesman for the district attorney's office in Suffolk County refused to comment on these reports. Edward Burke Jr, the high-profile lawyer representing Timberlake, had previously argued that the case against his client should be dismissed, claiming that the police made a series of important errors.

Burke had previously requested that the case against Timberlake be dismissed, arguing that a supervisor at the police station did not sign the paperwork presented to a new officer, which, according to him, was legally questionable.
