Tribunal ordena a Chiquita pagar R\$38 millones a familias de colombianos asesinados por escuadrón de la muerte

Un tribunal de Florida ordenó a Chiquita Brands International que pague R\$38 millones a las familias de ocho hombres colombianos asesinados por un escuadrón de la muerte paramilitar,

después de que la empresa bananera estadounidense fuera acusada de financiar la organización terrorista entre 1997 y 2004.

La histórica sentencia, pronunciada el lunes por la noche, se produjo después de 17 años de esfuerzos legales y es la primera vez que la multinacional de las frutas paga una indemnización a las víctimas colombianas, abriendo el camino para que miles de ellas busquen reparación.

Un precedente en derechos humanos

La sentencia también marca la primera vez que una gran corporación estadounidense es considerada responsable de tales abusos de derechos humanos en otro país y podría dar lugar a una serie de demandas similares relacionadas con violaciones de derechos en todo el mundo.

Un mensaje contundente

"Este veredicto envía un mensaje poderoso a las corporaciones en todas partes: el beneficio de los abusos de los derechos humanos no quedará impune", dijo Marco Simons en EarthRights, uno de los bufetes de abogados que representan a las familias de los asesinados por los paramilitares.

Una larga historia de financiación

Chiquita se declaró culpable en 2007 de financiar a "una entidad terrorista globalmente designada" al pagar secretamente al Autodefensas Unidas de Colombia (AUC) 1,7 millones de dólares durante siete años en la cúspide del conflicto colombiano, pero nunca antes se le había ordenado pagar una indemnización a las víctimas.

El coste de hacer negocios en Colombia

Los documentos judiciales muestran que Chiquita continuó pagando al AUC después de que fuera designado organización terrorista internacional en EE.UU. en 2001 y que los ejecutivos consideraban los pagos como "el coste de hacer negocios en Colombia".

Un paso importante en la lucha por la justicia

Este veredicto representa un paso importante en la lucha por la justicia y la rendición de cuentas de las empresas transnacionales que cometen abusos de derechos humanos en otros países.
